*International students are eligible for some scholarships and loan programs. Since identifying sources of degree funding can take some time, it's a good idea to begin your research early.*

## Scholarships and Loans

### Rollins Merit Scholarships

Rollins offers merit scholarships to outstanding applicants each year. All applicants, including international applicants, are considered for these awards if their complete application is received at Rollins by the application deadline.

## **Rollins Earn and Learn Program**

International students with F-1 visas may apply for a REAL Award in their first semester at RSPH. The program provides funding for eligible full-time MPH/MSPH students to support their academic interests with public health experience. Should the student receive the award, then it will be for their second semester of their first year of the program. To be considered for REAL during the second year, students may apply during the Spring semester of their first year at RSPH.
